Motion 1: The Antipodes play funding

The JCR notes:

The Antipodes is a 2017 play by the Pulitzer-winning playwright Annie Baker, and has never been performed in Oxford before. Natasha Hermer is part of the play's small cast.

- Pecadillo Productions, and the students involved, will not be benefiting financially from the production, as company members are unpaid, and any profits go directly towards funding future Oxford student productions.
- JCR funding is essential to allowing this production to go ahead, enabling us to fund key production expenses, preventing students from being personally out of pocket for their involvement.
- Pecadillo productions have already involved many freshers new to theatre in the production, both through an absurdism workshop in Michaelmas of freshers week and through the trainee scheme of the OUTTS (technical theatre society)

The JCR believes:

- Supporting the funding of The Antipodes is crucial for the success of the production
- This grant funding would go directly towards helping us fund the show's expenses, crucial to lowering the show's breakeven (the number of tickets we need to sell to avoid making a loss) and therefore helping the production to go ahead.



- This money will also help with accessibility to Oxford drama, as the production involves many individuals who have not taken part in Oxford drama previously. Funding grants will go towards reducing the financial burden on individuals who take part.
- Supporting student arts in Oxford benefits a wide variety of individuals and interests, allowing more shows to happen and therefore more individuals to get involved. The vibrant arts scene in Oxford is testament to the generous support of colleges across the university

5. Action motions for debate not asking for funding

Motion 1: The Cat Representative's Ballot

The JCR notes: the cat representative position is currently not eligible for a higher ballot point ranking despite being on the JCR committee.

The JCR believes: that the cat representative undertakes regular and significant responsibilities, including running the JCR's most followed Instagram page, ensuring the welfare of the college cats and maintaining consistent communication with junior dean Bethan Wallace, and has stepped up for other JCR members when they were overworked, (e.g. attending the library subcommittee meeting). The JCR also believes that it is unfair to demand weekly meeting attendance and consistent involvement from a role that is not recognised with the same benefits as others, and that withholding the privileges other JCR members enjoy both obfuscates the criteria through which such privileges are awarded and diminishes the dignity of the cat representative.

The JCR resolves to dispense justice and henceforth group the cat representative's ballot point ranking with the other members of the JCR committee
